I. Call to Order

V. Approval of Board of Directors Minutes from Saturday, June 22, 2019

The Board of Directors Regular Board Meeting Minutes of June 22, 2019 was distributed and reviewed via email prior to this meeting. Motion made by Maryann Muschlitz, seconded by Mike DeVita to accept the Minutes as written. All voted aye, motion passed.

VI. Approval of the Agenda

Motion made by Maryann Muschlitz, seconded by Marvin to accept the Agenda. All voted aye, motion passed.

VII. Treasurer's Report

Treasurer's report reviewed with all members, copies distributed. Motion made by Mario Aieta, seconded by Mike DeVita to accept the Treasurer's report. All voted aye with one abstention. Motion passed.

Motion made by Mario Aieta, seconded by Mike DeVita to approve the invoices as presented. All voted aye, motion passed.

VIII. New Business

A. Vicky Perrotta, chairman of the Membership/Nominations/Elections Committee reviewed the results of the election of the New ByLaws. 49 votes cast, 23 for, 26 against. The ByLaws vote failed.

B. Email votes by the Board since the last Regular Board Meeting are as follows:

Legal committee handling all community complaints confidentially, personal service expenditure for collection cases, Atty. Steih past bill, cover letter to the ByLaws, postage expenditures, special Board meeting, Atty. Farley expenditure, Staples paper and cartridge. Motion made by Marvin Schechter, seconded by Mario Aieta to ratify all email votes made by the Board as listed. All voted aye, motion passed.

C. Check Signing Authority

Motion made by Marvin Schechter, seconded by Maryann Muschlitz, to expand to four check signatories by adding 2 Board members with the main signatories being the Treasurer (Carol Gillen) and Secretary (Rose Murphy) in the first instance, and only if one is not available, we would need to use the 3rd or 4th signatory. All voted aye, motion passed.

Motion made by Mario Aieta, seconded by Paul Palladino to add Vicky Perrotta and Marvin Schechter as the two additional signatories to the Wayne Bank Checking Account. All voted aye, motion passed.

D. Insurance Designation of four Board members to be contacts. Issue tabled until next Board Meeting in August 2019.

E. Payment of dues and assessments and treatment of delinquency

A change to the Rules and Regulations proposed as follows:

Motion made by Mario Aieta, seconded by Carol Gillen, to revise the current collection procedure in Section 3, part B1 of the Rules and Regulations to read: "Landowners who have not paid their assessments by April 1 will incur a finance charge. Those who are in arrears on that date will be subject to referral for collection and for liens. If necessary, court action will be taken. These property owners forfeit their landowner rights." All voted aye, motion passed. This proposed change in the ByLaws will be brought to the Board for a vote at the next Board Meeting in August 2019.

F. Best Practices - financials

Zavada will be performing our full, external audit as previously agreed by the Board.
